

B98.7's "WIN \$125 WORTH OF GIFT CERTIFICATES TO TO THE TASTE OF 801 RESTAURANTS. PIONEER DAY LAGOON WEEKEND" WEEKEND TEXT CONTEST
OFFICIAL RULES

The Station will conduct the **B98.7'S "WIN \$125 WORTH OF GIFT CERTIFICATES TO TO THE TASTE OF 801 RESTAURANTS." WEEKEND TEXT CONTEST** (the "Contest") substantially as described in these rules, and by participating, each participant agrees as follows:

1. **NO PURCHASE IS NECESSARY TO ENTER OR WIN. A PURCHASE WILL NOT INCREASE YOUR CHANCE OF WINNING. VOID WHERE PROHIBITED. ALL FEDERAL, STATE, AND LOCAL REGULATIONS APPLY.**

Eligibility. All entries must be received by 11:59pm MT on August 31st, 2020 to be eligible for the Grand Prize drawing. **Standard text messaging rates, as established by an individual's wireless carrier, may apply, and Station assumes no responsibility for any fees or charges incurred for and associated with any text message sent to or from Station. Any and all fees arising out of the transmission of a text message shall be the sole responsibility of the entrant. Limit one (1) entry per person per phone number.** Multiple participants are not permitted to share the same telephone number. Any attempt by any participant to submit more than one (1) entry by using multiple/different telephone phone numbers, identities, or any other methods will void that participant from further participation in the Contest.
