## B98.7'S "FACEBOOK FRIEND OF THE DAY" CONTEST OFFICIAL RULES

1. NO PURCHASE IS NECESSARY TO ENTER OR WIN. A PURCHASE WILL NOT INCREASE YOUR CHANCE OF WINNING. VOID WHERE PROHIBITED. ALL FEDERAL, STATE, AND LOCAL REGULATIONS APPLY.

Eligibility. The daily Facebook post will be posted at 12:00pm MT. All entries must be received by 1:30 pm MT on October 30th, 2020 to be eligible to win. Limit two (2) entries per person per day per email address. Multiple participants are not permitted to share the same email address or Facebook account. Any attempt by any participant to submit more than one (2) entries per day by using multiple/different email addresses or Facebook accounts, identities, registrations and logins, or any other methods will void that entry and the participant may be disqualified.
