B98.7's "FACEBOOK FRIEND OF THE DAY" CONTEST OFFICIAL RULES

1. NO PURCHASE IS NECESSARY TO ENTER OR WIN. A PURCHASE WILL NOT INCREASE YOUR CHANCE OF WINNING. VOID WHERE PROHIBITED. ALL FEDERAL, STATE, AND LOCAL REGULATIONS APPLY.

Eligibility. The daily Facebook post will be posted at 12:00pm MT. All entries must be received by 1:30 pm MT on December 18th, 2020 to be eligible to win. Limit two (2) entries per person per day per email address. Multiple participants are not permitted to share the same email address or Facebook account. Any attempt by any participant to submit more than one (2) entries per day by using multiple/different email addresses or Facebook accounts, identities, registrations and logins, or any other methods will void that entry and the participant may be disqualified. Use of any automated system to participate is prohibited and will result in disqualification. - 4. **Winner Selection.** On or about 1:35 pm MT each weekday of the Contest Period, Station will select one (1) entry for a Prize (as defined below) in a random drawing from among all valid entries received by Station during the Contest Period as of the date and time of that drawing. The winning entrant will be contacted using the email address, Facebook messenger and/or telephone number provided with the entry and may be awarded the prize (subject to verification of eligibility and compliance with the terms of these rules). Station's decisions as to the administration and operation of the Contest and the selection of the potential winner are final and binding in all matters related to the Contest. Failure to respond to the initial verification contact within three (3) days of notification will result in disqualification and forfeiture of the prize.
