B98.7'S "LAGOON TEXT CONTEST" CONTEST OFFICIAL RULES

The Station will conduct the **B98.7**'s "LAGOON TEXT CONTEST" (the "Contest") substantially as described in these rules, and by participating, each entrant agrees as follows:

- 1. NO PURCHASE IS NECESSARY TO ENTER OR WIN. A PURCHASE WILL NOT INCREASE YOUR CHANCE OF WINNING. VOID WHERE PROHIBITED. ALL FEDERAL, STATE, AND LOCAL REGULATIONS APPLY.
 - Eligibility. Entrant agrees to receive messages from Station from time to time relating to the Contest, the Station, and any Contest sponsor or prize provider.
- 4. **Winner Selection.** On or about 7:00 AM MT on Each Weekday August 21 August 23, 2021, Station will select Four (4) winner from the previous days entries in a random drawing from among all valid entries received by Station during the Contest Period Each winning entrant will be contacted using the email address and/or telephone number provided with the entry and may be awarded the prize (subject to verification of eligibility and compliance with the terms of these rules).
