B98.7'S ESCAPE TO LAS VEGAS TO SEE ADELE" CONTEST OFFICIAL RULES

The Station will conduct the **B98.7's ESCAPE TO LAS VEGAS TO SEE ADELE" CONTEST** (the "Contest") substantially as described in these rules, and by participating, each entrant agrees as follows:

1. NO PURCHASE IS NECESSARY TO ENTER OR WIN. A PURCHASE WILL NOT INCREASE YOUR CHANCE OF WINNING. VOID WHERE PROHIBITED. ALL FEDERAL, STATE, AND LOCAL REGULATIONS APPLY.

Eligibility. This Contest is open only to legal U.S. residents of the Station's Designated Market Area ("DMA") as defined by Nielsen Audio, excluding Florida and New York residents, age twenty-one (21) years or older at the time of entry with a valid Social Security number, who have not won a prize from the Station in the last 24 Hours or a prize valued at \$500 or more in the last 90 Days, and whose immediate family members or household members have not won a prize from the Station in the last 24 Hours or a prize valued at \$500 or more in the last 90 Days. - 2. Contest Period. The Contest entry period will begin at 8:00 am MT on January 3, 2023 and will run through 5:00pm MT on January 13, 2023 (the "Contest Period"). The Station's computer is the official time keeping device for this Contest.

 - A. On Air/ Text: Listen to the station weekdays at <u>8A, 10A, 12p, 2P, and/or 4PM MT</u> during the Contest Period (each, a "Keyword Time"). Once each Keyword Time, when the Station announces the keyword for that Keyword Hour (each, a "Keyword"), listeners must send a text with that Keyword within Fifty-Nine Minutes (0:59) after each applicable Keyword Time to '68255'. All entries must be received within Fifty-Nine Minutes (0:59) after each Keyword Time, with the final entry due by 4:59pm MT Friday January 13th, 2023 to be eligible to win a prize. Message and data rates apply.
- 4. **Winner Selection.** On or about 7:00am MT on January 16, 2023, Station will select One (1) potential winner in a random drawing from among all valid entries received by Station during the Contest Period. The winning entrant will be contacted using the email address and/or telephone number provided with the entry and may be awarded the prize (subject to verification of eligibility and compliance with the terms of these rules). Station's decisions as to the administration and operation of the Contest and the selection of the potential winner are final and binding in all matters related to the Contest. Failure to respond to the initial verification contact within three (3) days of notification or failure to claim the prize within three (3) days of verification as a winner will result in disqualification and forfeiture of the prize.

- 5. Verification of Potential Winner.
