B98.7'S "FACEBOOK FRIEND OF THE DAY" CONTEST OFFICIAL RULES

The Station will conduct the **B98.7's "FACEBOOK FRIEND OF THE DAY" CONTEST** (the "Contest") substantially as described in these rules, and by participating, each entrant agrees as follows:

1. NO PURCHASE IS NECESSARY TO ENTER OR WIN. A PURCHASE WILL NOT INCREASE YOUR CHANCE OF WINNING. VOID WHERE PROHIBITED. ALL FEDERAL, STATE, AND LOCAL REGULATIONS APPLY.

Eligibility. (a) Visit the Station's Facebook page <u>www.facebook.com/b987SLC</u> and comment, like or share the daily Facebook "Friend of the Day" post. The daily Facebook post will be posted at 11:00am MT. All entries must be received by 1:30 pm MT daily during the contest period to be eligible to win.

Any entry comments that are indecent, lewd, offensive, defamatory, contain profanities, or are in any way in bad taste or contain material that may infringe or violate any laws or anyone's rights, as determined in the sole discretion of the Station, may be disqualified. Entry comments that are removed and/or blocked by Station and/or by Facebook will be deemed not entered in the Contest.

On or about 1:40 PM MT each weekday during the contest period. Station will select (1) one potential winner(s) in a random drawing from among all valid entries received by Station during the Contest Period Each winning entrant will be contacted messenger on facebook and may be awarded the prize (subject to verification of eligibility and compliance with the terms of these rules). Station's decisions as to the administration and operation of the Contest and the selection of the potential winner are final and binding in all matters related to the Contest. Failure to respond to the initial verification contact within three (3) days of notification or failure to claim the prize within three (3) days of verification as a winner will result in disqualification and forfeiture of the prize.
